5 Be It Enacted by the Legislature of the State of Wyoming:

6 Section 1. W.S. 11-20-225(c), 11-20-401 and
 7 11-20-402(a)(v) and (vi) are amended to read:

8 11-20-225. Annual horse brand inspection certificate;
 9 surrender to board; fee.

10 (c) For each permit issued under this section there
 11 shall be charged an inspection fee of two dollars--~~(\$2.00)~~

1 per--head--for--the--first--ten--(10)--head--inspected--and--one
2 dollar--(\$1.00)--for--each--additional--head--inspected--at--the
3 same--time--and--place AS PROVIDED BY W.S. 11-20-402.

4 11-20-401. Brand inspection fees generally.

5 (a) Except as otherwise provided, each livestock
6 inspector shall at the time of inspecting for brands and
7 ownership collect inspection fees in an amount established
8 by the livestock board but not to exceed:

9 (i) One-dollar--(\$1.00) ONE DOLLAR AND TWENTY
10 CENTS (\$1.20) per head on all cattle including unbranded
11 animals;

12 (ii) Twenty--cents--(\$0.20) TWENTY-FOUR CENTS
13 (\$.24) per head on all sheep except unbranded and undocked
14 lambs running with their mothers; and

15 (iii) Two--dollars--(\$2.00) TWO DOLLARS AND FORTY
16 CENTS (\$2.40) per head for the first ten (10) head of
17 horses inspected and one--dollar--(\$1.00) ONE DOLLAR AND
18 TWENTY CENTS (\$1.20) for each additional horse inspected
19 at the same time and place.

20 11-20-402. Miscellaneous inspection fees.

1 (a) The board, through its authorized inspectors,
2 shall collect the following fees for services rendered:

3 (v) Ten-dollars-~~(\$10.00)~~ TWELVE DOLLARS (\$12.00)
4 for each permanent brand inspection and movement permit
5 issued pursuant to W.S. 11-20-224;

(vi) Two--dollars--{\$2.00} TWO DOLLARS AND FORTY CENTS (\$2.40) per horse for the first ten (10) head inspected and one--dollar--{\$1.00} ONE DOLLAR AND TWENTY CENTS (\$1.20) for each additional head inspected under the annual horse brand inspection and movement permit issued pursuant to W.S. 11-20-225.

12 Section 2. This act is effective July 1, 1994.
