- 5 WHEREAS, Fitzsimons Army Medical Center serves 952,000
- 6 active duty military personnel, veterans and their depend-
- 7 ents in the twelve-state Fitzsimons Health Services Region
- 8 including Colorado, Illinois, Iowa, Kansas, Minnesota,
- 9 Missouri, Nebraska, North Dakota, South Dakota, Utah, Wis-
- 10 consin and Wyoming; and
- 11 WHEREAS, in addition to providing tertiary medical,
- 12 dental and preventive medical care services, Fitzsimons

- 1 provides medical education and training for both active
- 2 and reserve units; and
- 3 WHEREAS, Fitzsimons is the only military medical
- 4 training facility in this region of the country; and
- 5 WHEREAS, the Department of Defense has recently
- 6 announced that Fitzsimons has been chosen as one of twelve
- 7 centers for its health management regions as part of the
- 8 Department's health care reform efforts.
- 9 NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE LEG-
- 10 ISLATURE OF THE STATE OF WYOMING:
- 11 Section 1. That the Wyoming legislature supports the
- 12 Fitzsimons initiative in its efforts to move forward with
- 13 site preparation and secure construction appropriations
- 14 for the new Fitzsimons Army Medical Center replacement
- 15 hospital and a Defense Women's Health Research Center at
- 16 Fitzsimons, and urges the Wyoming Congressional delegation
- 17 to lend its support to these efforts.
