D-D soil fundgant is for use at full strength by injection in the soil for control of root knot, meadow, and sugar beet nematodes, wire worms and garden centipedes.

Under average conditions a dosage of 200 to 400 pounds per acre (depending upon type of pest to be controlled) should prove the most satisfactory.

As a safeguard against damaging plant life, application should be made at least fitteen days before planting. The soil injection should be made by use of efficient equipment with even dispersion.
