APPLICATION FOR THE REGISTRATION OF A TRADE MARK

To the Secretary of State,  
Cheyenne, Wyoming.

The undersigned, Joseph Di Santo, doing business as  
DI SANTO & CO., of 118 -4th Ave.W., - DULUTH, MINNESOTA, hereby  
makes application for the registration of a trade mark, the essential  
features of which are described as follows:

"MAZZINI" in any type and form, with or without the portrait of  
"MAZZINI"; that the word "MAZZINI" refers to the Italian Patriot  
and Statesman of that name, who was born at Genoa, Italy June 22,  
1805 and died at Pisa, Italy on Mar.10, 1872. It has been the custom  
to imprint the trade mark upon the labels or directly upon the  
containers for the goods or to display the mark in other ways cus-  
tomary to the trade.

The class of merchandise upon which the same has been used are FOOD  
PRODUCTS of all varieties, MEDICINAL PREPARATIONS, CIGARS and TOBACCO  
PRODUCTS, SOAPS, SUNDRIES, DRY and FRESH FRUITS and Vegetables,  
CEREAL BEVERAGE, NON-ALCOHOLIC MALTLESS BEVERAGES sold as Soft Drinks  
including GRAPE JUICE, GINGER ALE, LEMON SODA, etc.etc.

The right is claimed to use the same on all natural or manufactured  
articles produced, procured or selected by the said Joseph Di Santo.  
The right is claimed for the said trade-mark as a general trade-mark  
for property and material of every nature and description at the  
present time or intended to be associated with the said "MAZZINI"  
Brand in the future.

The above described trade mark has been in continuous use by said  
applicant since March 8, 1917.

Joseph Di Santo, does hereby declare that he has a right to the use  
of said trade mark and that no other person, firm, association, or  
corporation has the right to such use, or to the use of any trade mark  
similar thereto, and further declares that the facsimiles or copies  
filed herewith are true and correct.
