State Construction Department's Mission: To provide a diverse range of knowledge and expertise in the planning, design, construction and preservation of state facilities, the University of Wyoming, community colleges and K-12 educational facilities throughout Wyoming.

## Agency to Which Your Group Reports:

- **Construction Management Division -** State Building Commission (SBC)
  - Number of Members: The SBC is comprised of the state's five (5) elected officials: the governor (who chairs the Commission), secretary of state, state auditor, state treasurer and the superintendent of public instruction. The governor appoints four (4) members of the Wyoming Legislature to serve on the Commission in an ex-officio capacity: two (2) from the state Senate and two (2) from the House of Representatives.
  - Meeting Frequency: The SBC meets quarterly in Cheyenne, unless otherwise noted.
- o School Facilities Division School Facilities Commission (SFC)
  - Number of Members: The SFC is established to consist of eight (8) members: the state superintendent of public instruction (who serves in an ex-officio, nonvoting capacity), and seven (7) members who are Wyoming residents appointed by the governor (one (1) member appointed from each of the seven (7) appointment districts designated in W.S. 9-1-218(b)). Four (4) of the appointees shall have knowledge and experience in the following areas:
    - (i) Building and facility engineering, construction and operations
    - (ii) Building design and specifications
    - (iii) Estimating, bidding and building construction
    - (iv) School district administration
  - Meeting Frequency: The SFC meets every other month in various school districts across Wyoming.
