AN ACT making an appropriation for finishing and equipping the main building at the Wyoming State Hospital for Insane.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

Section 1. The sum of Ninety Thousand Dollars (\$90,000.00), or so much thereof as may be necessary is hereby appropriated out of any funds in the State Treasury not otherwise appropriated, for the purpose of finishing and equipping a new building for the Wyoming State Hospital for the Insane at Evanston, Wyoming, said amount to be expended under the supervision and direction of the State Board of Charities and Reform.

Section 2. This Act shall take effect and be in force from and after its passage.
