A BILL

AN ACT appropriating the sum of Twenty-five Thousand Dollars (\$25,000.00) to the Wyoming Statutory Revision Committee for the purpose of revising and recodifying the insurance statutes of the State of Wyoming and providing an effective date.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

Section 1. There is hereby appropriated to the Wyoming Statutory Revision Committee the sum of Twenty-five Thousand Dollars (\$25,000.00), or so much thereof as may be necessary to be used by the committee in carrying out a revision and recodification of the insurance statutes of the State of Wyoming.

Section 2. This bill shall take effect and be in force from and after its passage.
