9 (f) Effective July 1, 1995 every hospital, health
10 care facility, birthing center or other medical assistance
11 facility located in the state shall provide to any person

1 who holds himself out to be the natural parent of a child
2 born out of wedlock in the state an affidavit of paternity
3 and acknowledgement pursuant to subsection (c) of this

7 shall provide blank affidavits of paternity to any facil-
