Professional Teaching Standards Board

* Mission and philosophy

The mission of the Professional Teaching Standards Board (PTSB) is to ensure that every student is served by competent, ethical educators who meet rigorous performance standards. Its charge is to protect the citizenry by providing consumer protection for public school personnel in Wyoming. The PTSB acts in accordance with the highest standards of ethics, accountability, efficiency and openness. The board strives to provide firm and fair regulations with efficient and effective service.

* Results of outcomes

The Professional Teaching Standards Board has 26,627 certified education personnel (August 2000). A survey was sent to 10 percent of the new applicants. The results showed the Wyoming certification process is completed within a few weeks, and the staff is helpful.

The public has increased usage of the Web site, with an average of 858 requests per month. Clients have downloaded an average of 435 applications per month. The PTSB staff continually increases the use of e-mail to communicate with teachers as more school districts are connected.

In support of Senate Enrolled Act 33 and with a subsidy grant from the National Board for Professional Teaching Standards, the PTSB administrated support for teachers seeking National Board Certification. Three Wyoming teachers received certification after completing the certification application in 1999. In 2000, 24 teachers received the grant and 16 teachers completed the certification application process.

The board continues to support alternate certification, with a 260 percent increase in portfolio certification applications from last year. For the 1999-2000 school year, the board approved 108 requests by school districts for collaboration certification, a 55 percent increase, and 13 temporary permits, an 85 percent increase.

The PTSB is a member of a partnership with the University of Wyoming College of Education and the Wyoming School-University Partnership, which has received federal funding support. During the last year committees have worked to align teachers' standards to student standards in science, social studies, math and language arts. Thirty-seven new teachers were trained to assess portfolios. Approximately 187 teachers participated in focus groups to discuss quality teaching and renewal requirements and study the elements of quality teaching.

The PTSB continues to evaluate and approve workshops and school district staff development plans for renewal
