ORIGINAL HOUSE BILL NO. 206

ENROLLED ACT NO. 62, HOUSE OF REPRESENTATIVES

FORTY-SECOND SESSION OF THE STATE LEGISLATURE OF THE STATE OF WYOMING

AN ACT to amend section 39-161 of the statutes relating to the definition of cigarette wholesaler; and including in the definition wholesale purchasers of cigarettes within the state.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

Section 1. Section 39-161 of the statutes is amended to read:

39-161. Definitions. When used in this act:

- (a) "Wholesaler" means any person, firm, partnership, association; corporation or other entity who:
 - (i) Imports cigarettes into this state for sale or resale;
 - (ii) Purchases cigarettes within this state for sale to anyone other than the purchaser;
 - (iii) Purchases cigarettes for distribution sale or resale through mechanical Vending devices located in counties or municipalities other than the county or municipality where purchased;
 - (iv) The definition wholesaler shall not apply to

those persons who have vending devices, owned or leased by them, and which are located in their place of business.

- (b) The term "sale" or "sell" includes installment, credit and conditional sales, and means any exchange, barter or transfer of title or possession, or both, for a consideration to any other person, firm, corporation or other entity within the state of Wyoming.
- (c) "Consumer" means any person, firm, corporation or other entity who has title to, or possession of, cigarettes in storage for use or other consumption in this state.
- (d) The term "board" or "state board" means the state board of equalization of the state of Wyoming or any duly authorized employee of the same charged with the administration or enforcement of this act.
