SHOW CAUSE ORDER AND NOTICE
SETTING PUBLIC HEARING
(Issued December 1, 2020)

1. Pursuant to the Wyoming Administrative Procedure Act, the Wyoming Telecommunications Act, WYO. STAT. §§ 37-15-401(a)(ii), 37-2-117, 37-12-201 through 37-12-204, 37-12-211 through 37-12-212, and Wyoming Public Service Commission's (Commission) Rules, Chapter 2, Sections 5 and 23, Skype Communications US Corporation (the Company) is hereby ordered to appear at the public hearing to be held in the **Commission's Hearing Room, 2515 Warren Avenue, Suite 300, in Cheyenne, Wyoming, commencing at 9:00 a.m. on Thursday, January 7, 2021.** At this hearing, the Company shall be required to show cause why its registration authority to provide interexchange telecommunications services within the state of Wyoming, granted pursuant to WYO. STAT. § 37-15-201, should not be revoked and canceled due to the Company's violation of certain requirements and provisions of Wyoming law, as set forth below.

2. A review of the Commission's files discloses that the Company has failed to properly file its annual report with the Commission in violation of WYO. STAT. § 37-2-203(b), and Commission Rules Chapter 3, Section 32.

3. The Company is directed to appear at the public hearing, at the time and date specified above, to respond to the cited violations of Wyoming law, and advise the Commission of its proposed actions to remedy the violations. The Company's failure to correct the violations prior to the scheduled public hearing or its failure to appear at the public hearing, absent full compliance with the provisions of Wyoming law cited herein, shall result in default judgment being rendered against the Company and the immediate revocation and cancellation of its authority to provide telecommunications services within Wyoming.

4. The Company shall be allowed an opportunity to correct its noncompliance and violation of the referenced provisions of Wyoming law regarding the annual report filing requirement by contacting Mindy Inman, Wyoming Public Service Commission, 2515 Warren Avenue, Suite 300, Cheyenne, Wyoming 82002, in writing or by telephone at (307) 777-7426. Upon compliance with the Commission's annual reporting requirement, this show cause proceeding and public hearing will be canceled.

5. This *Show Cause Order and Notice Setting Public Hearing* is effective immediately.
