6 Be It Enacted by the Legislature of the State of Wyoming:

7 Section 1. W.S. 21-13-102(b) (intro) and by creating
 8 new paragraphs (v) through (vii) is amended to read:

9 21-13-102. Maximum rate of school district tax;
 10 recapture of excess; equalization of permissive levies.

11 (b) On January 15, March 15 and April 15 of each year

1 in equal payments of twenty-five percent (25%) and the
2 balance to be paid on June 15, each school district shall
3 rebate to the department of education the amount by which
4 the revenue from the sources provided by W.S. 21-13-310
5 exceeds ~~one-hundred-nine-percent-(109%)~~ THE PERCENTAGE of
6 the foundation program costs determined under W.S.
7 21-13-309 as SPECIFIED BY THIS SUBSECTION AND AS certified
8 to the districts on or before March 1 of the current fis-
9 cal year under subsection (e) of this section, to be cred-
10 ited to the public school foundation program account
11 defined in W.S. 21-13-101(a)(ix):-

12 (v) FOR SCHOOL YEAR 1994-1995, ONE HUNDRED SIX
13 PERCENT (106%);

14 (vi) FOR SCHOOL YEAR 1995-1996, ONE HUNDRED
15 THREE PERCENT (103%);

16 (vii) FOR SCHOOL YEAR 1996-1997 AND EACH SCHOOL
17 YEAR THEREAFTER, ONE HUNDRED PERCENT (100%).

18 Section 2. This act is effective July 1, 1994.
