

CHAPTER 170

Original House Bill No. 150

INSURANCE — RETALIATORY FEES

AN ACT to amend W.S. 26-3-130(b) and 26-4-101(a)(v)(A) introductory paragraph and (I) through (IV) and by creating a new subdivision (V), (B) introductory paragraph and (I) through (V), (ix) and (xi) relating to insurance; eliminating retaliatory fees for nonresident agents, adjusters, service representatives and consultants; increasing fees for agents, adjusters and service representatives; and providing for an effective date.

*Be It Enacted by the Legislature of the State of Wyoming:*

**Section 1.** W.S. 26-3-130(b) and 26-4-101(a)(v)(A) introductory paragraph and (I) through (IV) and by creating a new subdivision (V), (B) introductory paragraph and (I) through (V), (ix) and (xi) are amended to read:

**26-3-130. Retaliatory provisions against other states and countries.**

(b) This section does not apply to:

(i) Application fees, examination fees, license fees, appointment fees and continuation fees for agents, adjusters, service representatives or consultants; or

(ii) Personal income taxes, ad valorem taxes on real or personal property nor to special purpose obligations or assessments imposed by another state in connection with particular kinds of insurance other than property insurance, except that the commissioner shall consider deductions, from premium taxes or other taxes otherwise payable, allowed because of real estate or personal property taxes paid in determining the propriety and extent of retaliatory action under this section.

**26-4-101. Fee schedule.**

(a) The commissioner shall collect in advance fees, licenses and miscellaneous charges as follows:

(v) Agents:

(A) Property, casualty, surety, title insurance agents, and including disability insurance without additional license or fee when written by property, casualty or surety insurer otherwise represented by the agent:

Application for original license, and issuance of license, if issued .....	25.00
Annual continuation of license .....	25.00
(xi) Service representative:	
Application for original license, and issuance, if issued ..	\$25.00
Annual continuation of license .....	25.00
