ORDER FOR PUBLIC NOTICE

(Issued April 7, 2021)

1. The Wyoming Public Service Commission (Commission) hereby gives notice that Qwest Corporation d/b/a CenturyLink QC (CenturyLink QC) has made a contract filing requesting authority to amend its Interconnection Agreement with CenturyLink Communications, LLC for the State of Wyoming, and requests Commission approval pursuant to the provisions of 47 U.S.C. § 252(e)(1) of the Federal Telecommunications Act of 1996. The parties' amendment adds language to their existing Interconnection Agreement regarding Unbundled Network Elements to comply with a recent directive issued by the Federal Communications Commission.¹

2. Under 47 U.S.C. § 252(e)(2)(A)(i) and (ii), the Commission may reject a negotiated agreement, or any part of such agreement, if it finds [a] that the agreement, or any portion of it, discriminates against a telecommunications carrier not a party to the agreement, or [b] that the implementation of such an agreement, or portion of the agreement, is not consistent with the public interest, convenience and necessity.

3. This is not a complete description of the Amendment. The Amendment is on file with the Commission at its offices in Cheyenne, Wyoming, and may be inspected by any interested person during regular business hours.

4. If you wish to provide the Commission with a statement or other comment regarding this Amendment, please do so in writing on or before May 7, 2021. Thereafter, the Commission will further review the Amendment and any statements filed with respect thereto, and will decide its acceptability under the above criteria.
