6 *Be It Enacted by the Legislature of the State of Wyoming:*

8 **Section 1.** W.S. 31-18-305 is created to read:

9

10 **31-18-305. Operating time of drivers; rules; penalty.**

12 (a) No driver of a motor vehicle used to transport
13 railroad crews on a commercial basis shall operate any motor
14 vehicle for more than twelve (12) hours or be on duty for
15 more than fifteen (15) hours without having at least eight
16 (8) consecutive hours off duty.

1 (b) The department may adopt rules and regulations as
2 necessary to implement this section.

4 (c) Violation of this section is a misdemeanor
5 punishable by a fine of not more than seven hundred fifty
6 dollars (\$750.00). In the case of a repeated violation in
7 any three (3) year period, the department of transportation
8 after an opportunity for hearing, may issue an order
9 prohibiting the violating person or firm from transporting
10 railroad crews or restricting the violator's operations and
11 may petition the district court for an injunction enforcing
12 the order.

14 **Section 2.** This act is effective July 1, 1997.
