6 Be It Enacted by the Legislature of the State of Wyoming:

8 Section 1. W.S. 31-18-305 is created to read:

10 31-18-305. Operating time of drivers; rules; penalty.

- 12 (a) No driver of a motor vehicle used to transport
- 13 railroad crews on a commercial basis shall operate any motor
- 14 vehicle for more than twelve (12) hours or be on duty for
- 15 more than fifteen (15) hours without having at least eight
- 16 (8) consecutive hours off duty.

The department may adopt rules and regulations as 1 (b) necessary to implement this section. 2 3 a misdemeanor (c) Violation of 4 this section is punishable by a fine of not more than seven hundred fifty 5 dollars (\$750.00). In the case of a repeated violation in 6 7 any three (3) year period, the department of transportation after an opportunity for hearing, may issue an order 8 prohibiting the violating person or firm from transporting 9 railroad crews or restricting the violator's operations and 10 may petition the district court for an injunction enforcing 11 12 the order.
