

6 Section 1. W.S. 31-2-206 by creating a new subsection
7 (m) is amended to read:

8 31-2-206. Annual renewal; delivery of license plates
9 and stickers; staggered registration; temporary registra-
10 tion.

11 (m) UPON COMPLIANCE WITH W.S. 39-6-406 AND 39-6-506,

1 IF APPLICABLE, AN OWNER OF A NONCOMMERCIAL VEHICLE MAY, AS
2 AN ALTERNATIVE TO REGISTRATION, OBTAIN NOT MORE THAN ONE
3 (1) TEMPORARY REGISTRATION IN A TWELVE (12) MONTH PERIOD
4 AUTHORIZING OPERATION OF THE VEHICLE ON THE HIGHWAYS OF
5 THIS STATE FOR A PERIOD NOT TO EXCEED NINETY (90) DAYS
6 FROM THE DATE OF TEMPORARY REGISTRATION, IN LIEU OF PAY-
7 MENT OF THE ANNUAL REGISTRATION FEES IN W.S. 31-3-101.
8 APPLICATION FOR TEMPORARY REGISTRATION SHALL BE MADE TO

1 Section 2. This act is effective immediately upon
2 completion of all acts necessary for a bill to become law
3 as provided by Article 4, Section 8 of the Wyoming Consti-
4 tution.

8 31-2-206. Annual renewal; delivery of license plates
 9 and stickers; staggered registration; temporary registra-
 10 tion.

11 (m) AN OWNER OF A VEHICLE MAY, AS AN ALTERNATIVE TO

1 REGISTRATION, OBTAIN A TEMPORARY PERMIT AUTHORIZING OPERA-
2 TION OF THE VEHICLE ON THE HIGHWAYS OF THIS STATE FOR A
3 PERIOD NOT TO EXCEED ONE HUNDRED TWENTY (120) DAYS FROM
4 THE DATE OF THE ISSUANCE OF THE PERMIT, IN LIEU OF PAYMENT
5 OF THE ANNUAL REGISTRATION FEES IN W.S. 31-3-101. APPLICA-
6 TION FOR THE TEMPORARY PERMIT SHALL BE MADE TO THE COUNTY

17 (.30);

18 (iv) UP TO ONE HUNDRED TWENTY (120) DAYS AT
19 FOUR-TENTHS (.40).
