### **Licensing Report for Oct – Dec 2018**

I visited NM BON Nov 5-8 2018 to see ORBS in action. This was a very informative trip to see how it operates and what their experiences were as they went through data migration and the go live phase. I talked with each section and learned “what to do” and “what not to do” as we move forward with implementation.

The licensing section is actively reviewing the applications and data in the ORBS test environment and learning to use/navigate the ORBS system for when we go live.

We are also cleaning up our portion of the database in KNURSE for preparation to migrate to ORBS system in Jan 2019.

We will not accept paper applications postmarked after Jan 11, 2019. From Jan 19 to Jan 28 we will be entering all applications that we have and cleaning up loose ends for the migration. WBSN will GO LIVE with ORBS on Jan 28, 2019.
