SECTION 1. Section 2022, Mynding Compiled Statutes.

10.0, relating to Exemptions from Taxation, is dereby amended and re-enacted to read as follows:

"Section 2322. Exemptions - Taucational - Fraternal - Charitable. Section 1. Section 2323, Wyoming Compiled Statutes,

and re-enacted to read as follows:

"Section 2302. Exemptions—Educational—Franternal—Charitable. Lands, with buildings thereon, used or owned by schools, orphan asylums or hospitals, or by any secret, benevolent, fraternal, or charitable society or association, shall be exempted from taxation, so long as the rents, issues, profits and revenues derived therefrom are used for the purposes of such school, orphan asylum, hospital, secret, benevolent, fraternal or charitable society or association."
