AN ACT to amend and re-enact Section 2322, Wyoming Compiled Statutes, 1910, relating to exemptions from taxation.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

SECTION 1. Section 2322, Wyoming Compiled Statutes, 1910, relating to Exemptions from Taxation, is hereby amended and re-enacted to read as follows:

"Section 2322. Exemptions - Educational - Fraternal - Charitable. Lands, with buildings thereon, used or owned by schools, orphan asylums or hospitals, not used for private profit, or by any secret, benevolent, fraternal, or charitable society or association, shall be exempted from taxation, so long as the rents, issues, profits and revenues derived therefrom are used for the purposes of such school, orphan asylum, hospital, secret, benevolent, fraternal or charitable society or association."

SECTION 2. This Act shall take effect and be in force from and after its passage.

AN ACT TO AMEND AND RE-ENACT SECTION 2322, WYOMING COMPILED STATUTES, 1910, RELATING TO EXEMPTIONS FROM TAXATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

Section 1. Section 2322, Wyoming Compiled Statutes, 1910, relating to Exemptions from Taxation, is hereby amended and re-enacted to read as follows:

"Section 2322. Exemptions--Educational--Fraternal--Charitable. Lands, with buildings thereon, used or owned by schools, orphan asylums or hospitals, or by any secret, benevolent, fraternal, or charitable society or association, shall be exempted from taxation, so long as the rents, issues, profits and revenues derived therefrom are used for the purposes of such school, orphan asylum, hospital, secret, benevolent, fraternal or charitable society or association."

Section 2. This Act shall take effect and be in force from and after its passage.
