AN ACT to amend and re-enact Section 20 of Chapter 62, Session Laws of Wyoming, 1939, related to foreign corporations.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

Section 1. That Section 20 of Chapter 62, Session Laws of Wyoming, 1939, be amended and re-enacted to read as follows:

Section 20. Any PRIVATE BUSINESS corporation organized under the laws of ANY JURISDICTION OTHER THAN THE STATE OF WYOMING OR THE UNITED STATES OF AMERICA which transacts business in this state without first complying with the provisions of Section 28-141, REVISED STATUTES OF WYOMING, 1931, shall be precluded from maintaining any action in tort or contract upon any claim related to, concerned with, or arising out of any business transacted in this state in violation of the provisions of Section 28-141, REVISED STATUTES OF WYOMING, 1931.

Section 2. This Act shall take effect and be in force upon and after its passage.

AN ACT to amend and re-enact Section 20 of Chapter 62, Session Laws of Wyoming, 1939, related to foreign corporations.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

Section 1. That Section 20 of Chapter 62, Session Laws of Wyoming, 1939, be amended and re-enacted to read as follows:

Section 20. Any PRIVATE BUSINESS corporation organized under the laws of ANY JURISDICTION OTHER THAN THE STATE OF WYOMING OR THE UNITED STATES OF AMERICA which transacts business in this state without first complying with the provisions of Section 28-141, REVISED STATUTES OF WYOMING, 1931, shall be precluded from maintaining any action in tort or contract upon any claim related to, concerned with, or arising out of any business transacted in this state in violation of the provisions of Section 28-141, REVISED STATUTES OF WYOMING, 1931.

Section 2. This Act shall take effect and be in force upon and after its passage and approval.
