7 Be It Enacted by the Legislature of the State of Wyoming:

8 Section 1. W.S. 39-1-201(a) by creating a new para-  
 9 graph (xxxii) is amended to read:

10 39-1-201. Exemptions enumerated.

1           (a) The following property is exempt from property  
2   taxation:

3                    (xxxii) ANY IMPROVEMENT TO RESIDENTIAL PROP-  
4    ERTY MAKING ENTRANCE TO OR COMMON FACILITIES WITHIN THE  
5    PROPERTY MORE ACCESSIBLE TO A HANDICAPPED PERSON.

6           Section 2. This act is effective immediately upon  
7   completion of all acts necessary for a bill to become law  
8   as provided by Article 4, Section 8 of the Wyoming Consti-  
9   tution.
