NOTICE OF PETITION (Issued November 19, 2021)

- 1. The Wyoming Public Service Commission (Commission) hereby gives notice of the *Petition* of Qwest Corporation d/b/a Century Link QC (Qwest or the Company) for authority to eliminate Performance Indicator Definitions (PIDs) and Performance Assurance Plan (PAP) from its Interconnection Agreements (ICAs) with each Wyoming Competitive Local Exchange Carrier (CLEC).
- 2. On October 11, 2021, Qwest filed its *Petition*, requesting authority to eliminate PIDs and PAP from its interconnection agreements, effective on the date of the Commission's order. The Company also requests that all existing interconnection agreements that currently contain the PIDs and PAP be modified to incorporate this change, effective on the same day.
- 3. PIDs are performance measurements used to provide specific data about service quality. These PIDs are designed to be used to ensure that the Company's PAP standards for service quality are maintained after the Company's approval to enter the Inter-Local Access and Transport Area (InterLATA) market under 47 U.S.C. § 271. These PIDs and the PAP became exhibits to Qwest's ICAs offered to CLECs.
- 4. The Company's proposal is made due to the decline in CLEC orders for services under the PAP, rendering the program obsolete. Payments to CLECs under the PAP have been less than \$200 since 2014, with most years having no payments.
- 5. This is not a complete description of the Petition. Interested persons may inspect the Petition at the Commission's offices in Cheyenne, Wyoming, by visiting the Commission's website at https://psc.wyo.gov.
- 6. Anyone wishing to file a statement, intervention petition, protest or request for a public hearing in this matter must do so in writing filed with the Commission on or before December 20, 2021. Any intervention request filed with the Commission shall set forth the grounds of the proposed intervention or request for hearing as well as the position and the interest of the petitioner in this proceeding. Please be sure to mention Docket No. 70000-1737-TA-21 (Record No. 15954) in all correspondence with the Commission.
- 7.
