## A BILL for

1 AN ACT to amend and re-enact Subsection (10) of Section 21-68, Wyoming  
2 Statutes 1957, relating to the annual computation of local dis-  
3 trict resources for the purposes of the school foundation program,  
4 to provide for the exclusion of any tuition received for the  
5 education of mentally or physically handicapped children from  
6 such annual computation.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

8 Section 1. Subsection (10), Section 21-68, Wyoming Statutes  
9 1957 is amended and re-enacted to read as follows:

10 (10) Seventy-five per cent (75%) of the amount of tuition paid  
11 to the district during the previous school year including such amounts  
12 as it may be required to charge under the provisions of section 67-217;  
13 ~~Wyoming-Compiled-Statutes, 1945,~~ 21-52, WYOMING STATUTES 1957, as amended;  
14 PROVIDED, THAT NO DISTRICT SHALL INCLUDE IN ITS ANNUAL COMPUTATION OF  
15 THE SUM OF LOCAL DISTRICT RESOURCES ANY TUITION PAID TO THE DISTRICT  
16 DURING THE PREVIOUS SCHOOL YEAR BY ANOTHER DISTRICT FOR THE EDUCATION  
17 OF PUPILS WITH ANY MENTAL OR PHYSICAL HANDICAP BECAUSE OF SERVICES AVAIL-  
18 ABLE IN THE RECEIVING DISTRICT.
