- 15 or to an employer of the former employee is presumed to be
- 16 acting in good faith. Unless lack of good faith is shown by

2 civil liability for the disclosure or for the consequences

3 resulting from the disclosure.

5 (b) For purposes of subsection (a) of this section,

6 the presumption of good faith is rebutted upon a showing

7 that the information disclosed by the former employer was

8 knowingly false or deliberately misleading or was rendered

9 with malicious purpose.


