LETTER ORDER NUNC PRO TUNC

(Issued April 21, 2020)

On May 21, 2019, the Wyoming Public Service Commission (Commission) incorrectly issued a Letter Order changing the name of Integrated Services, Inc. to Electric Lightwave, LLC d/b/a Allstream. The name change request was opened under Docket identifier 74655 and should have been opened under Docket identifier 74236. After reviewing the original request the Commission has determined that the name change issued under 74655 should revert back to its original name of Integrated Services, Inc. The correct name change will be issued under Docket No. 74236-11-TA-20 which changes the name Electric Lightwave, LLC d/b/a Integra Telecom to Electric Lightwave, LLC d/b/a Allstream. A copy of the Notification Letter and this *Letter Order* will be placed in the Commission's docket files.

IT IS THEREFORE ORDERED:

1. The name change of Integrated Services, Inc. to Electric Lightwave, LLC d/b/a Allstream will revert back to Integrated Services, Inc. The correct name change request of Electric

Lightwave, LLC d/b/a Integra Telecom will be correctly changed to Electric Lightwave, LLC d/b/a Allstream, is accepted for filing.

2. This *Letter Order* is effective immediately.
