These funds shall be expended from any monies available which are not required for payments on outstanding bond issues, obligated for economic development investments or required for administrative expenses of the authority. If the authority determines it does not have four million dollars (\$4,000,000.00) available as defined above, it shall submit a report to the economic development and stabilization board stating that it does not have four million dollars (\$4,000,000.00) available as defined above and indicate what amount of funds are available for such purposes.".

"Section 1. An amount not to exceed five million dollars (\$5,000,000.00) under the control of the Wyoming community development authority and certified by the state examiner to be available and approved by the governor shall be deposited to the revolving investment fund account created by W. S. 9-9-102 and shall be expended for economic development projects as directed and identified by the Wyoming investment fund committee created by W. S. 9-9-104. The funds deposited pursuant to this section shall be expended from monies certified which are not required for payments on outstanding bond issues, obligated for economic development investments or required for administrative expenses of the Wyoming community development authority.".
