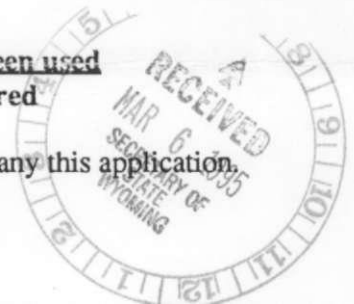

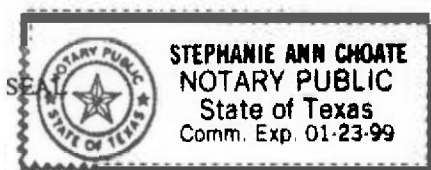

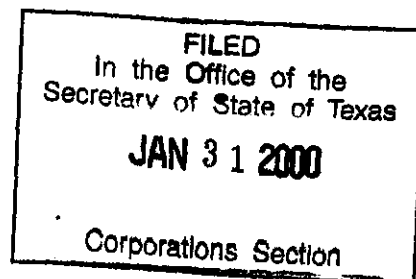

TO THE
