This matter came before the Wyoming Public Service Commission (Commission), upon Cheyenne Light, Fuel and Power Company, d/b/a Black Hills Energy (CLFP) and Black Hills Power, Inc., d/b/a Black Hills Energy's (BHP) *Unopposed Motion to Consolidate (Motion)* requesting to consolidate Docket No. 20003-177-ET-18 (Record No. 15170) and Docket Nos. 20002-111-EN-18 and 20003-178-EN-18 (Record No. 15171).

A scheduling conference was held regarding Docket Nos. 20002-111-EN-18 and 20003-178-EN-18 (Record No. 15171) on March 8, 2019, and the Parties assured the hearing officer that these dockets were interrelated with overlapping witnesses and, for purposes of efficiency, could be consolidated and heard within two days. At its March 19, 2019, regular Open Meeting, the Commission considered the *Motion*. Based on Staff's recommendation to grant the *Motion*, and there being no objection, the Commission granted the *Motion*.

IT IS THEREFORE ORDERED:

1. Pursuant to Open Meeting action taken on March 19, 2019, Docket No. 20003-177-ET-18 (Record No. 15170) and Docket Nos. 20002-111-EN-18 and 20003-178-EN-18 (Record No. 15171) are hereby consolidated for all purposes.
