A BILL

for

1 AN ACT to appropriate the sum of \$150,000.00 for short  
2 term vocational training programs; and providing for an  
3 effective date.

4 Be It Enacted by the Legislature of the State of Wyoming:

5 Section 1. There is hereby appropriated from any  
6 funds in the state treasury not otherwise appropriated the  
7 sum of one hundred fifty thousand dollars (\$150,000.00) to  
8 the state superintendent of public instruction for short  
9 term vocational education programs for the fiscal year  
10 beginning July 1, 1977 and ending June 30, 1978.

11 Section 2. This act is effective July 1, 1977.
