14 sheep, on any land within any national forest, national park or  
15 national game refuge within the boundaries of the State of Wyoming,  
16 any part of which is open to the hunting of deer, elk, moose or  
17 mountain sheep at any time during the calendar year in which said  
18 hunting is done, unless accompanied by a licensed guide provided
