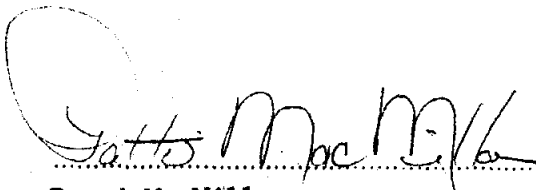

5 Be It Enacted by the Legislature of the State of Wyoming:

6 Section 1. W.S. 13-3-203(d) is amended to read:

7 13-3-203. Borrowing.

8 (d) NOTWITHSTANDING ANY LIMITATIONS CONTAINED IN
 9 SUBSECTION (a) OF THIS SECTION any bank ~~that-is--a--member~~

1 ~~of-the-federal-reserve-system~~ may borrow money FROM A FED-
2 ERAL RESERVE BANK on its bills payable and may rediscount
3 any note or negotiable instrument in the manner required
4 by the rules, laws and regulations of the federal reserve
5 banks.

6 Section 2. This act is effective May 27, 1983.
