Our office has been in communication with Linda Dickens of your office this past week concerning the filing of applications for registration of tradenames and trademarks or service marks for Wyoming Bancorporation and its member banks.

In regard to the registration of tradenames for banks, we have been informed that the Secretary of State does not register bank names as this is a responsibility of the State Bank Examiner. For our records, we would appreciate verification of this policy.

In regard to the registration of a trademark or service mark, please find enclosed the applications signed on behalf of Wyoming Bancorporation to register its trade or service mark, and the trademark or service mark for the First Wyoming Banks. Two separate checks in the amount of \$10 each are enclosed for the filing fees.

When I checked with Mrs. Dickens yesterday in regard to the filing of these applications for trade or service marks, she informed me that there was some question as to whether the applications would be approved. She was concerned that the logotype would not qualify as a "trademark" or "service mark". Wyoming Statute 40-7.1 defines trademark as "...any word, name, symbol, or device or any combination thereof...." Wyoming Statute 40-7.1 defines service mark as "...a mark used in the sale or advertising of services to identify the services of one person and distinguish them from the services of others." Wyoming Statute 40-7.2, which provides an enumeration of those marks which cannot be registered, does not apply to these applications. We respectfully Mrs. Thyra Thompson
