Insert additional paragraph at end of Section 1, to read as follows: The State Board of Control shall, upon petition for an amended certificate of appropriation of water, where a change of lane description is requested, except in case of cherical errors, cause a public hearing to be held on said potition before the Superintendent of the Water Division in which such appropriation is located, and notice of said hearing to be advertised in at least one issue of a newspaper having general circulation in the community where the water right involved is situated. The petitioner shall pay the cost of such advertisement prior to the time of hearing and provide a stenographic record of proceedings to be transmitted by the Division Superintendent to the State Board of Control, together with his report thereon. At the time of filing the petition s fee of two dollars, the same as in the original adjudication, shall be collected by the State Board of Control Per each amended certificate of uppropriation of water issued and a deposit of sufficient funds to cover the cost of preparing and recording a certified copy of the order of said Board granting such petition; provided that the fees for recording shall be returned to the putitioner in case the petition is not granted.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

Section 1. That Section 122-415, Wyoming Revised Statutes, 1931, be amended and re-enacted as follows:

Section 122-415. The state engineer is hereby authorized, upon written *** PETITION *** of the owner, to *** AMEND *** any permit *** TO APPROPRIATE WATER PRIOR TO AD-JUDICATION BY THE STATE BOARD OF CONTROL FOR THE PURPOSE OF CORRECTING ERRORS OR OTHERWISE, WHEN IN HIS JUDGMENT SUCH AMENDMENT APPEARS DESIRABLE OR NECESSARY; PROVIDED THAT THE TOTAL AREA OF LANDS MAY NOT EXCEED THE AREA DESCRIBED IN THE ORIGINAL PERMIT.

THE STATE BOARD OF CONTROL IS HEREBY AUTHORIZED, UPON THE WRITTEN PETITION OF THE OWNER, TO ISSUE AMENDED CERTIFI-CATES OF APPROPRIATION FOR WATER RIGHTS THAT HAVE BEEN ADJUDI-CATED, FOR THE PURPOSE OF CORRECTING ERRORS OR OTHERWISE. WHEN IN THE JUDGMENT OF THE SAID BOARD IT APPEARS DESIRABLE OR NECESSARY; PROVIDED THAT THE TOTAL AREA OF THE LANDS MAY NOT EXCEED THE AREA DESCRIBED IN THE ORIGINAL CERTIFICATE OF

APPROPRIATION; AND PROVIDED, FURTHER, THAT THE AMENDED AREA MAY NOT EXCEED THE AREA ACTUALLY IRRIGATED UNDER THE ORIGINAL RIGHT; AND PROVIDED, FURTHER, THAT THE RIGHTS OF OTHER APPROPRIATORS NOT BE INJURIOUSLY AFFECTED THEREBY. (See Amend.)

Section 2. That Section 122-401, Wyoming Revised Statutes, 1931, as amended and re-enacted by Chapter 25, Session Laws of Wyoming, 1941, be amended and re-enacted to read as follows:

Section 122-401. A water right is a right to use the water of the state, when such use has been acquired by the beneficial application of water under the laws of the state relating thereto, and in conformity with the rules and regulations dependent thereon. Beneficial use shall be the basis, the measure and limit of the right to use water at all times, not exceeding the statutory limit except as provided by Section 122-117 Revised Statutes of Wyoming, 1931, as amended by Chapter 105, Section 1, Session Laws of Wyoming, 1935. Water being always the property of the state, rights to its use shall attach to the land for irrigation, or to such other purposes or object for which acquired in accordance with the beneficial use made for which the right receives public recognition, under the law and the administration provided thereby. Water rights for the direct use of the natural unstored flow of any stream cannot be detached from the lands, place or purpose for which they are acquired, except as provided in Sections 122-402 and 122-403, Revised Statutes of Wyoming, 1931, pertaining to a change to preferred use, AND EXCEPT AS PROVIDED IN SECTION 1 OF THIS ACT.

Section 3. This Act shall take effect and be in force from and after its passage.
