6 *Be It Enacted by the Legislature of the State of Wyoming:*

8 **Section 1.** W.S. 22-6-116 and 22-19-103 are amended to
9 read:

11 **22-6-116. Printing type size of party and candidate**
12 **names.**

14 On official ballots and ballot labels the political party
15 name or title shall be printed in capital letters not less
16 than one-eighth (1/8) inch nor more than one-fourth (1/4) of
17 an inch in height. The names of all candidates shall be
18 printed in the same size letters not less than one-eighth

1 (1/8) inch nor more than one-fourth (1/4) of an inch in
2 height. The name of each political party shall be printed in
3 the same type size as that of every other political party.

5 **22-19-103. How names of electors to appear; crediting**
6 **of votes.**
7

8 The names of presidential electors shall appear in each
9 general election proclamation and notice with the names of
10 their presidential and vice-presidential candidates but need
11 not appear on the ballot. ~~The surnames of the presidential~~
12 ~~and vice-presidential candidates shall be printed on the~~
13 ~~general election ballot in boldface letters not less than~~
14 ~~one-eighth inch nor more than one-fourth of an inch in~~
15 ~~height. The first names shall be printed in the same size~~
16 ~~letters, in lightface type.~~ The number of votes received by
17 presidential and vice-presidential candidates is the number
18 of votes credited to their electors.


