15 name or title shall be printed in capital letters not less

16 than one-eighth (1/8) inch nor more than one-fourth (1/4) of

1 (1/8) inch nor more than one-fourth (1/4) of an inch in 2 height. The name of each political party shall be printed in 3 the same type size as that of every other political party.

5 22-19-103. How names of electors to appear; crediting 6 of votes.

The names of presidential electors shall appear in each 8 general election proclamation and notice with the names of 9 their presidential and vice-presidential candidates but need 10 not appear on the ballot. The surnames of the presidential 11 and vice-presidential candidates shall be printed on the 12 general election ballot in boldface letters not less than 13 one-eighth inch nor more than one-fourth of an inch in 14 height. The first names shall be printed in the same size 15 letters, in lightface type. The number of votes received by 16 presidential and vice-presidential candidates is the number 17
