NOTICE OF APPLICATION (Issued June 6, 2017)

Pursuant to the Wyoming Administrative Procedure Act and the Wyoming Public Service Commission's (Commission) Rules, the Commission hereby gives notice of the application of Questar Gas Company d/b/a Dominion Energy Wyoming (Dominion or the Company) for approval to incorporate existing Wobbe indices into its tariffs.

- 1. Dominion is a public utility as defined by Wyo. Stat. § 37-1-101(a)(vi)(D), subject to the Commission's jurisdiction pursuant to Wyo. Stat. § 37-2-112.
- 2. In 1987, Dominion set Wobbe Indices for the points on its system. In 2012, under Docket No. 30010-125-GA-12 (Record No. 13393), Dominion sought Commission approval to establish Wobbe indices, consistent with points set in 1987. In its Order issued June 20, 2013, the Commission approved Dominion's request and established the Wobbe Indices.
- 3. On June 1, 2017, Dominion filed its application for approval to incorporate its previously established Wobbe Indices into its Tariff. The application is filed pursuant to Commission Rule Chapter 3, Section 1(c)(v) and 2.
- 4. This is not a complete description of the application. The Application is on file at the Commission's offices in Cheyenne, Wyoming, and at Dominion's business office at 1005 D Street, Rock Springs, Wyoming, and may be inspected by any interested person during regular business hours.
- 5. Anyone wishing to file a statement, intervention petition, protest or request for a public hearing in this matter must do so in writing filed with the Commission on or before July 3, 2017. Any intervention request filed with the Commission shall set forth the grounds of the proposed intervention or request for hearing as well as the position and the interest of the petitioner in this proceeding. Please be sure to mention Docket No. 30010-166-GT-17 (Record No. 14740) in all correspondence with the Commission.
- 6.
