7 Section 1. W.S. 20-2-113 by creating a new subsec-
 8 tion (c) is amended to read:

9 20-2-113. Disposition and provision for children in
 10 decree; grandparent visitations.

1 (c) SUBSEQUENT TO THE DEATH OR REMARRIAGE OF ONE (1)
2 OR BOTH PARENTS OR AFTER A DIVORCE OR JUDICIAL SEPARATION,
3 THE COURT MAY, UPON PETITION OF A GRANDPARENT, GRANT REA-
4 SONABLE VISITATION RIGHTS TO THE GRANDPARENT OF THE CHIL-
5 DREN, IF THE COURT FINDS, AFTER A HEARING, THAT THE VIS-
6 ITATION WOULD BE IN THE BEST INTEREST OF THE CHILD. THE
7 RELATIONSHIP OF THE GRANDPARENT TO THE PERSON HAVING CUS-
8 TODY IS NOT A FACTOR IN GRANTING VISITATION RIGHTS.

9 Section 2. This act is effective June 5, 1984.
