5 Be It Enacted by the Legislature of the State of Wyoming:

6 Section 1. W.S. 6-3-203(e) is amended to read:

7 6-3-203. Cruelty to animals; penalties; limitation on
 8 manner of destruction.

9 (e) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION,
 10 cruelty to animals is a misdemeanor punishable by impris-
 11 onment for not more than six (6) months, a fine of not

1 more than seven hundred fifty dollars (\$750.00), or both.
2 except-that A PERSON CONVICTED OF CRUELTY TO ANIMALS UNDER
3 SUBSECTION (a) OR (b) OF THIS SECTION IS GUILTY OF A FEL-
4 ONY PUNISHABLE BY NOT MORE THAN TWO (2) YEARS
5 IMPRISONMENT. A FINE OF NOT MORE THAN FIVE THOUSAND DOL-
6 LARS (\$5,00.00), OR BOTH, IF THE CONVICTION CONSTITUTES A
7 SECOND OR SUBSEQUENT CONVICTION WITHIN FIVE (5) YEARS OF A
8 PRIOR CONVICTION UNDER SUBSECTION (a) OR (b) OF THIS SEC-
9 TION OR A SIMILAR LAW OF ANOTHER JURISDICTION. Aggravated
10 cruelty to animals as defined by paragraphs (c)(ii), (iv),
11 (v) and (vi) of this section is a felony punishable by not
12 more than two (2) years imprisonment, a fine of not more
13 than five thousand dollars (\$5,000.00), or both.

14 Section 2. This act is effective July 1, 1993.
