## U.W. Art Museum Master Teacher Endowment Challenge

In 2007 with WCTF support, the University of Wyoming Art Museum piloted a Master Teacher position in its education program. The Master Teacher works with preK-12 teachers and students on investigative museum teaching and learning curricula that supports classroom goals and Wyoming Education Standards. This dynamic approach as seen an increase in students who not only visit the U.W. Art Museum but who have very specific opportunities for tying their experience at the Museum with their classroom lessons. The success of the pilot program resulted in temporary funding of the position for 5 years...and a challenge to raise endowment

This year the WCTF is pleased to help kick off a new endowment campaign with a \$40,000 challenge. The ultimate goal of the endowment campaign is a \$4 million fund which will support the Master Teacher as an endowed position. For more information about the U.W. ## Wyoming Music Educators Association

The Wyoming Music Educators Association (WMEA) members include Kindergarten - 12th grade, college/university, and private music instructors throughout the state of Wyoming. The membership is diverse by geography, grade level and area of expertise. Public, private and parochial teachers are represented in their active, collegiate, and retired membership. WMEA is a non-profit 501(c)(3) association. WMEA is the state unit of NAME: the National Association for Music Education, the largest arts advocacy organization in the world. The intent of the association is to offer professional development for music teachers, provide opportunities for all music students to explore and excel in the arts, and to serve as an advocate for music education in the schools of Wyoming.

This year, the Wyoming Cultural Trust Fund is pleased to assist WMEA with support for their Executive Manager position. In the past 30 years the Executive Manager has gone from a rotation-elected volunteer treasurer to an elected executive management position with a \$2,000 annual stipend. As the demands of the Executive Manager have increased over time, along with the required expertise with finances, programs and services, conferences, policies and federal regulations, there was a need to direct more resources to supporting this important position. The WCTF is supplying a multi-year grant to allow time for the financial resources to be identified and allocated, and to allow the organization to continue to benefit from a dedicated individual.
