1 (a) Upon application, the appropriate licensing 2 authority shall issue to the commissioner of agriculture a malt beverage permit for the sale of malt beverages only 3 4 on the state fairgrounds during the state fair. W.S. 5 12-5-201 does not apply to this subsection. The issuance 6 of a malt beverage permit under this subsection shall not 7 be considered an alcoholic beverage permit issued on the 8 basis of population as provided in W.S. 12-4-201. The board may 10 acquire by donation or lease in the name of the state any lands necessary for conducting the state fair, and may 11 12 make all rules and regulations necessary for the conduct 13 and government of the exhibitions, the sale of privileges, 14 and the proper control, operation and conduct of the state 15 fair not inconsistent with the constitution and laws of 16 this state. The board shall not permit any 3 gambling device of any nature to be operated on the 4 grounds, or permit any unlawful betting, or permit any 5 intoxicating liquors to be sold thereon EXCEPT AS PROVIDED 6 BY W.S. <u>12-4-505</u>.

Section 3. This act is effective June 8, 1989.


