4 Be It Enacted by the Legislature of the State of Wyoming:

5 Section 1. W.S. 39-3-101(b) is amended to read:

6 39-3-101. When taxes due and delinquent; notice or
 7 demand unnecessary.

8 (b) The balance of any tax not paid as provided by
 9 subsection (a) of this section is delinquent after the day

1 on which it is payable and shall bear interest at ~~eighteen~~
2 THE MOST RECENT INTEREST RATE ON UNITED STATES TREASURY
3 BILLS AS OF THE TIME OF DELINQUENCY AS DETERMINED BY THE
4 STATE BOARD OF EQUALIZATION PLUS TWO percent ~~(18%)~~ (2%)
5 per annum until paid or collected.

6 Section 2. This act is effective April 1, 1987.
7 Interest rates formerly provided by W.S. 39-3-101(b) shall
8 continue to apply to delinquent taxes prior to April 1,
9 1987, until the taxes are paid and collected. The inter-
10 est rates provided by the amendment to W.S. 39-3-101(b)
11 apply only to taxes which become delinquent on and after
12 April 1, 1987.
