Section 1. Section 887, Chapter 10 of the Revised Statutes of 1899 is hereby amended and re-enacted to read as follows: Sec. 887. To amend and re-enact Sec. 887, Chapter 10 of the Revised Statutes of 1899 relating to the Board of Control- Duties and Powers.

Be it enacted by the Legislature of the State of Wyoming:

Section 1. That Section 887, Chapter 10 of the Revised Statutes of 1899 be amended and re-enacted to read as follows: The Secretary of the Board of Control shall collect the following fees, which shall be paid in advance, and paid to the State Treasurer, and credited to the contingent fund of the Board of Control; for making certified transcripts of the records of the Board of Control or of papers or documents filed with said Board, one dollar for the first folio and fifteen cents for each additional folio. For attaching certificate and seal of the Board to each transcript, one dollar. ✓
