

A BILL

For

AN ACT limiting administrative expenses of the workmen's Compensation Department of the State Treasurer's office for the two years ending June 30, 1959, and providing for a control of such expenditures.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

Section 1. The Workmen's Compensation Department of the State Treasurer's office is authorized to expend from the Industrial Accident Fund not to exceed Two Hundred Eighty-nine Thousand Eight Hundred Fifty-nine Dollars (\$289,859.00) for administrative expenses in carrying out the provisions of the workmen's Compensation Act for the two years ending June 30, 1959.

Section 2. The workmen's Compensation Department shall comply with the provisions of the Budget Act insofar as expenditures for administrative purposes are concerned.
