5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:
6	Section 1. Subsection (b) of Section 152, Chapter 111,
7	Session Laws of Wyoming 1969, is hereby amended and re-enacted
8	to read as follows:
9	(b) Continuing Contract Teacher:
10	(i) Any initial contract teacher who has been
11	employed by the same school district in the State of Wyoming for
12	a period of three-(3) FOUR (4) consecutive school years,
13	including the time before and after the passage of this act, and
14	has had his contract renewed for a fourth FIFTH consecutive
15	school year; or
16	(ii) A teacher who, either before or after the passage
17	of this act has achieved continuing contract status in one
18	district, and who has taught $two-(2)$ THREE (3) consecutive
19	school years and has had his contract renewed for a third
20	FOURTH consecutive school year by the employing school district.
