6 Section 1. W.S. 5-5-108 is amended to read:

7 5-5-108. Supreme court to adopt rules and to estab-
 8 lish fees and court costs as specified; rules of civil and
 9 criminal procedure for county courts to govern courts. The
 10 Wyoming supreme court shall ~~adopt-rules-governing-the~~ MAN-

1 AGE AND SUPERVISE THE COUNTY COURTS OF THE STATE AND SHALL
2 BY RULE OF THE SUPREME COURT, ESTABLISH procedures and
3 ~~practices~~ REGULATIONS FOR THE EFFECTIVE AND EXPEDITIOUS
4 ADMINISTRATION OF THE BUSINESS of the county courts AND
5 UNLESS OTHERWISE PROVIDED BY LAW, ESTABLISH FEES AND COSTS
6 FOR THE COUNTY COURTS. The Wyoming Rules of Civil Proce-
7 dure FOR COUNTY COURTS and the Wyoming Rules of Criminal
8 Procedure FOR COUNTY COURTS, as amended or supplemented
9 from time to time, shall govern county courts. ~~unless-such~~
10 ~~rules--or--any--parts--thereof--are--declared--inapplicable--by~~
11 ~~the-supreme-court-~~ Commissioners, as used in the Wyoming
12 Rules of Criminal Procedure, shall include county court
13 judges and county court commissioners.

14 Section 2. This act is effective May 22, 1987.
