A BILL

for

1 AN ACT to amend section 21-484 by creating a new subsection  
2 (a) and renumbering existing subsections (a) and (b)  
3 as (b) and (c) of the statutes relating to community college boards; specifying the number of members of a board; and providing an effective date.

6 Be It Enacted by the Legislature of the State of Wyoming.

7 Section 1. Section 21-484 of the statutes is amended by creating a new subsection (a) and renumbering existing subsections (a) and (b) as (b) and (c) to read:

10 21-484. Number of board members; election; subdistricts; apportionment.

12 (a) EACH COMMUNITY COLLEGE DISTRICT BOARD SHALL CONSIST OF SEVEN (7) MEMBERS TO BE ELECTED AS PROVIDED BY LAW.

15 (a) The community college district board may by

1 resolution partition the community college district into  
2 election subdistricts to provide for representation on the  
3 district board in accordance with population. Where popu-  
4 lation figures permit, monetary evaluation and geographic  
5 factors may be considered in determining subdistricts.

6 ~~(b)~~ (c) The community college district board shall by  
7 resolution designate the number of members of the district  
8 board which shall be elected from each election subdis-  
9 trict, if any, in accordance with the population of the  
10 community college district and the respective election  
11 subdistricts.

12 Section 2. This act is effective immediately upon  
13 passage.
