BY W.S. 31-2-204(b) WHICH SHALL BE OF A SIZE AND LOCATION 9 ON THE LICENSE PLATE AS DETERMINED BY THE DEPARTMENT. THE 10 ARABIC NUMERALS DESIGNATING THE COUNTY OF ISSUANCE SHALL 11 NOT BE REQUIRED ON A PRESTIGE LICENSE PLATE ISSUED UNDER 12 THIS SECTION.
