LETTER ORDER (Issued October 10, 2016)

Dear Mayor Varney:

On August 24, 2016, the City of Torrington (Torrington) filed its Service Schedule M Total Power Requirements Power Purchase Agreement entered into with Municipal Energy Agency of Nebraska (MEAN) (Agreement). Commission Rule, Chapter 3, Section 31, provides:

Each utility shall file all special contracts governing the utility's sale of utility service or purchase of the commodity for resale. If a utility has numerous similar sale or purchase contracts, it may request to file one or a few representative special contracts in lieu of filing all such contracts.

Torrington's contract filing came before the Commission pursuant to due notice at its open meeting on September 29, 2016. John Burbridge, Commission Counsel, recommended accepting the Agreement for filing.

The Commission's authorization to place this Agreement in its files does not constitute the Commission's determination of any utility rate making issues whatsoever, which issues are expressly reserved for decision until they are presented regularly to the Commission in appropriate proceedings.

IT IS THEREFORE ORDERED:

- 1. Pursuant to open meeting action taken September 29, 2016, the City of Torrington's Service Schedule M Total Power Requirements Power Purchase Agreement is accepted for filing.
 - 2. This *Letter Order* is effective immediately.
