1 AN ACT relating to unemployment benefits and to provide that unemploy-
2 ment benefits shall be payable to a person otherwise qualified for
3 such benefits after having received temporary total disability
4 compensation under the Wyoming Workmens Compensation Law.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WYOMING:

6 Section 1. Notwithstanding any requirements involving base
7 periods or other such compensational factors as provided under Title 27,
8 Chapter 3, Wyoming Statutes 1957, as amended, a person who has had a
9 continuous period of sickness or injury resulting in his temporary total
10 disability and for which he was compensated under the Workmens
11 Compensation Law of this State shall, if he is otherwise eligible, there-
12 after be entitled to receive such unemployment compensation benefits as
13 he would have been entitled to receive under the law and regulations
14 based on his potential eligibility at the time of his last employment;
15 provided, however, that his benefit rights shall not be preserved under
16 this provision unless he files a claim for benefits with respect to a week
17 not later than the fourth calendar week of his unemployment occurring
18 after the end of such continuous period of sickness or injury; and he files
19 such claim with respect to a week within the thirty-six (36) month period
20 immediately following the commencement of such period of sickness or injury.
